Σας διαβιβάζουμε επιστολή του Παγκόσμιου Οργανισμού Υγείας, με την οποία καλούνται τα κράτη – μέλη της Ευρωπαϊκής Περιφέρειας να υποβάλουν υποψηφιότητες για τη θέση του Διευθυντή του Περιφερειακού Γραφείου για την Ευρώπη (Regional Director –WHO Regional Office for Europe).

Η εκλογή του Διευθυντή υα διεξαχθεί στην 64^η Σύνοδο της Περιφερειακής Επιτροπής για την Ευρώπη, η οποία θα λάβει χώρα 15- 18 Σεπτεμβρίου 2014. Οι υποψηφιότητες θα πρέπει να έχουν φθάσει στα Κεντρικά Γραφείου του ΠΟΥ έως την Παρασκευή 14 Φεβρουαρίου 2014.

Κατά τη διαδικασία υποβολής υποψηφιοτήτων, οι ενδιαφερόμενοι θα πρέπει να δηλώσουν εάν επιθυμούν να συμμετάσχουν σε ηλεκτρονική πλατφόρμα ερωταπαντήσεων (question and answer web forum) που θα δημιουργηθεί για το σκοπό αυτό στην ιστοσελίδα του ΠΟΥ.

Σημειώνεται ότι η Διεύθυνση Διεθνών Σχέσεων – Τμήμα Α΄ - Ανάπτυξης Διεθνούς συνεργασίας θα συλλέξει ενδεχόμενες υποψηφιότητες και θα ενημερώσει αρμοδίως του ΥΠΕΞ,

The Director-General of the World Health Organization presents her compliments to Members of the European Region and has the honour to refer to Rule 47 of the Rule of Procedure of the Regional Committee for Europe (hereinafter the "Rules of Procedure"), a copy of which is attached herewith, concerning proposals for the names of candidates for nomination by the Committee for the post of Regional Director.

In accordance with Rule 47.3 of the Rules of Procedure, not less than eleven months before the date fixed for the opening of a session of the Committee at which a person is due to be nominated as Regional Director, the Director-General shall inform each Member of the Region that she will receive proposals of names of candidates for nomination by the Committee for the post of Regional Director. In accordance with Rule 47.4 of the Rules of Procedure, such proposals as well as particulars of the person's qualifications and experience, shall be sent to the Director-General so as to reach her not less than seven months before the date fixed for the opening of the session of the Regional Committee. Further, in accordance with Rule 47.5 of the Rules of Procedure, a person holding office as Regional Director shall, if he or she is eligible, and has so requested within the same time frame referred to in Rule 47.3 (i.e., not less than eleven months before the date fixed for the opening of the session of the Regional Committee), be a candidate for nomination without being proposed under Rule 47.4.

The sixty-forth session of the Regional Committee for Europe is to be held at the Regional Office for Europe in Copenhagen, Denmark from 15 to 18 September 2014. The Director-General shall therefore receive, for consideration by the Regional Evaluation Group appointed by the Regional Committee at its sixty-third session and, in turn, by the Regional Committee, any such proposals for the names of candidates, provided that these reach her in Geneva, as referenced above, not later than the closure of working hours on Friday, 14 February 2014. Any such proposals must be accompanied by particulars of each person's qualifications and experience.

As provided by Section B II, paragraph 11 of the Code of Conduct for the Nomination of the Regional Director of the European Region of the World Health Organization (hereinafter the "Code"), after the Director-General has dispatched the names and particulars of candidates to Members in accordance with the provisions of Rule 47.9 of the Rules of Procedure, she will open on the web site of WHO a password-protected question-and-answer web forum open to all European Members and the candidates who request to participate in such a forum. When submitting proposals, Member States are therefore kindly requested to indicate whether the persons proposed for the post of Regional Director are willing to participate in the question-and-answer web forum. A password and instructions related to the use of the web forum shall be provided to Members in the communication referred to in this paragraph.

As provided by Section B II paragraph 12 of the Code, after the Director-General has dispatched the names and particulars of candidates to Member States, the Regional Office will post on its web site information on all candidates who so request including their curricula vitae and other particulars of their qualification and experience as received from Member States, as well as their contact information and the relevant rules and decision points pertaining to the nomination process as per Rule 47 of the Rules of Procedure. The web site will also provide links to individual web sites of candidates upon request: Each candidate will be responsible for setting up and financing his/her own website. When submitting proposals Member States are therefore kindly requested to indicate whether the persons proposed for the post of Regional Director are willing to post their curricula vitae, other particulars of their qualifications and experience, their contacts, as well as links to their individual websites if applicable, on the website of the Regional Office.

The Director-General takes this opportunity to renew to the Members of the European Region the assurance of her highest consideration.
